***Treasurer's Report**-No report at this time. Treasurer has been very sick. Will present at next meeting.

Old Business

- **Golf Tournament Update- Kenny May**
- We have 2 Bronze sponsors so far, also have approximately 32 golfers- everyone needs to keep handing out the flyers and keep trying to get more golfers- saturate the area with flyers- hand out to everyone we know.
- Chris Zilar has secured a "Hole in One" car- more prizes are in the works.
- Hole Signage- Kenny says we can sell for \$75 for a sign on the green, or \$100-\$200 for a sign per hole, also may want to look at other options for selling advertisement- up to us and the committee.
- "American Hole in One"- we could hire them to get 5-6 other hole prizes- hotel, trips, car, etc. –just another option to look into if we want
- List of volunteers- James Mitchell will head up volunteer committee- we need at least 10 to help with event that day. Discussion included whether or not we could/should use students to help- option to pay them with "Booster Bucks"- Boosters will have to decide.
- Staging of event- Kenny will help that day- placement of sponsor banners, etc. – we will need someone to do a video clip- (approx 2 min) that can be played during the event, or have a speaker. We will work on getting video clip of marching season- Melinda has.

- Table brochure- we will need to have someone at a table with promoters, sponsors, who donated, etc.
- Prizes- we need to decide what prizes should be and assign someone to work on- probably need about \$600 for 1st, 2nd and 3rd place. Anyone know any trophy places that could donate?
- Other options- Long shot, closest to the pin, - awards for that
- Appoint an MC- JD Hill will be there?
- Golfers bag- Kenny will get bags donated, what should go in them? Can we get things donated? Susie will look into Chap Stick- need other options- Kenny will contact pro golf place to see if they can help
- P.R. Promo- need 1 person to do a promo with JD Hill on radio- should have a script for what needs to be said.
- Probably should meet 4 times- 2 other times besides the next 2 booster meetings.
- Erin Toth moved that we meet at McCormick Ranch Golf Club at 6:00 pm on March 7th. Melinda Contreras 2nd. – We will be notified once Kenny confirms that we can visit that night to see the course.
- Need more paying golfers- everyone get the word out

New Business

- **Project Grad-** Erin Toth- need everyone's help in providing for Project Graduation. Anything we all can do to help will benefit.
- **Fundraising Ideas-** Will dedicate a portion of March's meeting to fundraising. Need to look at 50th Anniversary items, t-shirts.
 - **Yard Sale-** James will look at available times for a community yard sale in the church parking lot
 - **Spring Event for Students-** We can do a bowling event at the bowling alley on Thomas and Scottsdale Rd.- \$16.33 per person from 7-9 pm includes shoes, bowling and all you can eat pizza. Susie Riddlebarger moved that we do a bowling event on April 1st. Steve Riddlebarger 2nd. Discussion included if we have enough money to pay if there are a lot of students who want to attend. Existing money from the "Red Envelopes" will be used. Students must be current on fees in order to attend. Motion carried.
- **Budget- Sharon has reworked how the budget looks- so there is a shift in how the budget will be presented.**
 - Budget is still a hot topic. How to get students to pay in order to participate is a challenge. We will be putting a line item in for each item we need to pay for – but may be putting student fees and expected charges in student area now instead of general fund.
 - Went through budget line items to make adjustments to make budget balance.
 - Bob Ingram moved to accept budget as presented. Kris Starr 2nd. Discussion included how to pay for spring event for kids. Bob amended motion to include \$216.97 to general fund for social function. Melinda Contreras 2nd. Motion carried.
