Old Business

- **Band Camp**- Thank you to all who helped make this successful. Special thanks to Lori Mitchell for organizing the menu. Lori, in turn, thanked all who helped on a daily basis. Doc and the kids really appreciate it.
- **Golf Tournament Update**- Lee McGhee will serve as Chairperson. They have checked into different golf courses and have decided for several reasons to stay with McCormick Ranch- they have the best price and the best fit for our needs.
 - The date will be April 28, 2012 – and it will be an early morning tee off (7:00).
 - The committee wants to start now and pick up on the hype of the 50th Anniversary
 - They want to get a Paypal link to make it easier for people to sign up and pay
 - They would like \$2000 for start up money. They are hoping to put this in as a regular line item in the budget in the future. This would be for the down payment and miscellaneous expenses.
 - They were asked to define miscellaneous- to itemize for postage, gift bags, printing, etc.
 - Bob Ingram moved to amend this year's budget to allow for \$2000 to go to the Golf Tournament- with \$1000 as the deposit, \$250 for printing, \$250 for trophies, and to itemize the other \$500. Susie Riddlebarger 2nd. Motion carried.

New Business

- **Volunteers for Marching Season**- There are many opportunities, from concessions, to hydration, pit, sales, etc. Please sign up for any of them you can help with. We need help.
- **Truck rental Vs. Trailers**- Doc checked on liability if we have personal vehicles haul trailers with equipment. Legal says if personal trucks are pulling trailers, that person is responsible. We cannot get cargo coverage through Penske. We can transport props separately, but Bob says they will fit in the truck. Truck rental comes out of student accounts, and was included in the "Fair Share" portion fees.

- **Committees-** will continue to pass around signup sheets and ask people to volunteer on various committees. We need more volunteers on most sheets.
- **Fry's Cards and Alberstons' Community Partners-** we need to continue to support these efforts for fundraising- no risk involved and brings in a little profit for the group.
- **Canopy-** Steve Riddlebarger took care of the broken canopy from Big 5- they gave gift card to get replacements.
- **Doc-** gave update on band members- there are many conflicts with schedules which has limited the number of band students in the morning classes. He only has about 18 students for both bands combined. Has pleaded with administration to look at changes in scheduling. Cannot perform concerts with that low of group. Divisions are also changing for marching band- he does not yet know where we will be or who we will be competing against.
