Secretary Report:

Minutes from last meeting were passed around. No changes requested. Chris Zilar moved to accept minutes, seconded by Melinda Contreras.

Treasurer's Report:

Report passed around.

- We are about \$400 short on money owed to Hayden School Supply. Discussion on what should be done. We should pay the money we have received from students and contact those who have not paid. Possibly take back shoes/gloves/equipment from students who have not paid- since we will end up paying the bill. Need to make sure this does not happen next year. Hayden School Supply needs to collect money from students, not bill boosters.
- Still have people who have not paid for band camp. Hard for boosters to track who is who and who has not paid because we don't know all the kids. Suggestion made to give wrist band on first day of band camp to those who have paid. They will need to wear wrist band all week. This would help identify those who have paid.
- Mlee Martineau moved to accept Treasurer report, seconded by Steve Riddlebarger

Old Business/ Updates:

- **Golf Tournament**-Steve Riddlebarger- the meeting went very well- Kenny May/Event Source will help move the committee along. We need more help on the committee- about 5 or 6 more people.

- This is a BIG deal- we are hoping to raise \$25K –this can be an annual event and can be a big money maker for the band
- We need to have a separate account to track expenses and income- from our regular account. Steve Riddlebarger moved that we have an account set up, with officers having signing authority. Mlee Martineau seconded. Motion carried.
- April 30th is the tentative date for the event at McCormick Ranch Golf Course.
- Susie Riddlebarger is looking for auction items- anything and everything can be used- please ask people you know for donation of goods and/or services.
- Possibly get the band (or portion of band) to play at the event
- Steve and committee would like to name it. Suggestions include: First Annual Birdie for the Band and Band out of the Bunker. Please try to brainstorm ideas.
- Erin Toth has said she can help promote the event many ways through the PTO.

New Business

- We needed to book a flight for Mr. Matt to be here for Super State. The cost was \$227. We will need to vote to pay for it, or raise the money another way. Bob Ingram moved that we pay the cost, Mlee Martineau seconded. Bob amended to say to used from a fund designated by the treasurer. Motion carried.
- There is a \$100 fee for Super State- Mlee Martineau moved that we pay the fee, seconded by Bob Ingram. Motion carried.
- Would like to see more recognition for the award-winning band. Parents are encouraged to email William Gerchick to ask that band be recognized in the newspaper- the Coronado Explorer.
